Cost is \$80 for both discipline or \$50 for single discipline (plus day attendance fee of \$10.00 if applicable)

Pony Club Riders must present their current membership card for inspection prior to riding. All Open Riders must complete a Public Liability Declaration form. \$10.00 day attendance fee is due for each day unless you are a financial member* of EV/EA; AHS; SHCA; AERA; HRCAV an Interstate Pony Club; or can prove Personal Liability Cover of at least \$10,000,000. *Must provide proof (current membership card or insurance policy).

Riders without adequate insurance (not personal medical) pay \$10 per day for Liability Only Cover and complete the Participant Waiver.

Neither the organising committee of this clinic nor the instructors nor the PCAV nor the landowners accepts any responsibility whatsoever for any accident damage, injury or illness to horses, riders, ground spectators or any other person or property.

The Organising Committee reserves the right to cancel any class; alter times; refuse any entry with or without stating a reason. The \$50.00 is a non refundable deposit applies – further monies paid will be refunded upon presentation of a Medical or Veterinary Certificate.

- The Clinic will run under PCV rules and entering this Clinic constitutes your acceptance of these rules.
- Every child under 18 years must have a parent or guardian present whilst riding
- Dress Code: Approved riding helmets & boots, no singlet tops
- All riders (including non PCV members) must be gear checked
- Medical armbands must be worn by all riders
- Membership cards must be presented at the club rooms prior to riding
- Horses must be at least 4 years old, no stallions, colts or rigs
- Lunging at this clinic must be in the area designated by the organising committee
- PCV Alcohol Policy applies

- PCV horse abuse rules apply
- Portable yards are permitted to be built in designated area as per PCV rules. Stabling and yards should be of solid construction. The use of electrified tape, strings, ropes or chains, is not permitted. Electric tape can be used as a top line "standoff" on a steel or solid yard, but not as a standalone yard.
- PCV multiple horse rules apply
- Correct 'standards' numbered helmet must be worn as specified in <u>PCA Rules</u>. Spot checks may occur and incorrect helmet will mean elimination of rider.
- Shepparton Pony Club has a strict 'no dogs' policy due to the close proximity of the Harness Racing Stables
